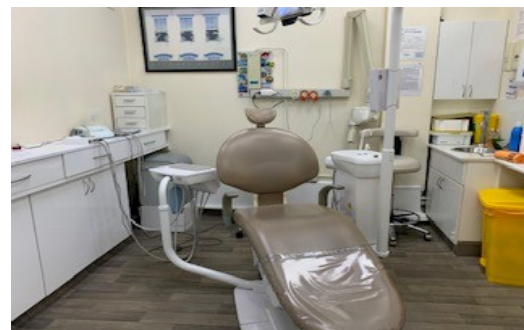

Location
